## Section 2 – Hazard(s) Identification

### 2.1 Classification of the substance or mixture

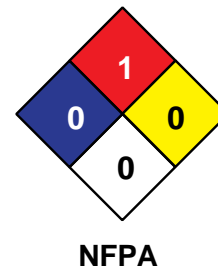
