SURFACE PREPARATIONS AND SYSTEMS

Previously painted surface in good condition: Wash down with Super Cleaner, rinse with fresh water and allow to dry. Abrade with 280-320 grade paper. **Poor surface condition**: Remove all previous coatings and prime the substrate.

PRIMING: Substrate preparation is covered separately on the primer datasheet.

GRP: Wash down with Super Cleaner, rinse with fresh water and allow to dry. Use Prekote undercoat, or if applying by spray use polyurethane Basecoat.

STEEL: Prime with Interprotect or Yacht Primer.

BARE WOOD: Prime with Yacht Primer or UCP.

ALUMINIUM: Prime with Etch Primer followed by Yacht Primer or Interprotect.

METHOD: Sand he undercoat smooth with 320-4-- grade wet or dry paper. Remove dust with a dust wipe. Apply 1-2 coats.
